DCPA24 Frequently Asked Questions

Q. What Is DCPA?

A. Digital CPA is an annual conference that brings together some of the most innovative minds in the accounting industry for collaboration, information sharing, networking, and insightful sessions about the future of the accounting profession and emerging tech/trends.

Q. When is DCPA?

A. DCPA will take place on Sunday, December 8th to Wednesday, December 11th, 2024.

Q. Where is DCPA?

A. DCPA will be hosted at the Hyatt Regency Denver at Colorado Convention Center in Denver, Colorado.

Q. Can I attend DCPA Online?

A. Yes! Please register here: https://www.cpa.com/digital-cpa/registration

Q. What Is Pack 7?

A. Pack 7 is a discounted DCPA registration type that means you can choose 7 virtual sessions and gives you access to all the keynote sessions.

Q. How many CPE credits does DCPA24 have?

A. Up to 22 CPE credits.

Q. Are there discounts for hotels we stay at?

Q. When does the conference room rate expire?

A. Conference room rate expires Nov 15, 2024, or when room block sells out, whichever comes first.

Q. How do I find conference material afterwards?

A. All conference materials can be located in your aicpaconference account.

Q. Is there an app for the conference?

A. The DCPA24 app will be made available to attendees a few weeks before the conference.

Q. Will I get CPE if I watch recorded sessions later?

A. No, during the conference there are checkpoints you must click to get your CPE. So, if you're not there to click on those you wouldn't get the credits.

Q. Where do I select individual sessions to attend?

A. As we near the conference, you will be sent an email about how to access the DCPA24 app. You will be able to pick your sessions on the app.

Q. Are there group discounts?

A. Yes! For groups of 2 -5, you can save an additional \$100 per person. For groups of 6 or more, you can save an additional \$200 per person.

Q. When does the Super Early Bird discount expire?

A. Our Super Early Bird Discount ends on July 31st, 2024.

Q. What's the refund policy?

On-Site: You may cancel without penalty if your cancellation request is received up to and including 45 days prior to the start of the conference. Due to financial obligations incurred by CPA.com, a credit less 50% of the registration fee will be issued for requests received up to and including 21 days prior to the start of the conference. No refunds or credits will be issued on cancellation requests received less than 21 days prior to the start of the event.

Online: You may cancel and receive a refund if your cancellation request is received up to and including 15 days prior to the start of the conference. You can cancel and receive a 100% credit if your cancellation is received up to and including 7 days of the start of the conference. Due to financial obligations incurred by CPA.com, a 60% credit will be issued for requests received up to the day prior to the start of the conference. No refunds or credits will be issued on cancellation requests received once the online conference begins.

Switching between On-site & Online: You may switch your attendance from on-site to online or vice versa within 10 days of the start of the conference. Please note if you switch from onsite to virtual the cost will remain the same. If you switch from virtual to onsite you will be required to pay the cost difference.

Q. Will there be vendors at the conference?

A. Yes, sponsors and vendors will be located in our Resource Center at the event.

Q. How do I become a sponsor?

Q. How do I pick my sessions?

A. After you register, you will receive an email a few days before the conference that has an app to pick the different sessions.

A. Speaker submissions for the 2024 Digital CPA Conference are now closed. However, if you'd like to submit for the 2025 Digital CPA Conference, we recommend reaching out to us in January of next year.

Q. When will the DCPA app be available?

A. We will send out an email with information about the app closer to the conference.
